

# To Our Stakeholders:

We are very proud of our efforts this past year to make a difference for the organizations we serve and the communities we support. We believe we are making a difference throughout the Triangle by helping nonprofits achieve their missions.

We help generate solutions that solve problems or address issues that arise in organizations. In 2011, we completed 57 consulting assignments for our clients, made possible in part by the generous financial grants from 7 local foundations.

Our strong results were achieved through the generous donation of time by our 35 pro bono consultants who provide our clients with professional consulting services that are tailored to meet their individual needs.

In addition, our Triangle BoardConnect service helps connect nonprofits with outstanding area professionals and executives seeking to share their time and talent by becoming a member of a Board of Directors. In 2011, our "board matchmaking" website of 492 candidate profiles was available to Triangle nonprofits seeking to fill some 358 open Board positions.

2011 marks our 25th anniversary of service. While our early efforts were modest in scale, our organization has grown to enable us to positively impact organizations in all four local counties; and we continue our reputation for quality consulting and professionalism.

In 2011, we sensed a need for greater collaboration among nonprofits as the economic downturn continued to affect most nonprofits' missions and critical funding of their good work. To validate this need, we surveyed Triangle nonprofits on their collaboration needs, and organized the first community-wide meeting on collaboration. We are proud of these initial steps, and see great promise in helping organizations learn more about the collaboration process.

We are also fortunate to have 4 new directors join our Board this past year. These committed and talented community leaders enhance our already strategic Board, one that can provide the leadership and governance needed for the future.

# **BOARD RETREAT FACILITATION** Woods Charter School

Founded in 1998, Woods Charter School is a grade K-12 public school located in Chatham County. Today, the school is proud of its 95 percent graduation rate and its ranking for SAT scores among the "top ten" schools in the entire state.

When Harrell Rentz became principal of the school a few years ago, the organization had just moved into its new facility. "Our feeling was that Woods Charter School was very good, but could become great," Rentz said. "Since so much of the Board's energy had gone into building the new facility, it was time to step back and begin thinking about our future and where we wanted to take the school next."

Rentz engaged ESC to conduct a Board of Directors retreat to begin the process of envisioning what the school could become, and also further develop the board through the formation of committees to help with the overall work and governance.

"The result of that first Board retreat was so successful," Rentz said, "that we engaged ESC to do an additional retreat one year later. We felt that the ESC consultants had done a great job in helping us with our committee structure and direction the first time, and we knew they could help us again as we began to address our mission and vision issues."

Rentz praised the professionalism of the consultants, describing them as efficient, flexible and knowledgeable. "They came in with great ideas, but also were good at listening to us and tweaking their ideas to make it work best for us. I think our Board was already very effective and functional, but they helped us get to the next level."

Rentz and the Board also felt that it was valuable to have consultants from outside the culture of the organization come in to help with the process, individuals with no agenda who could challenge group thinking.

# **STRATEGIC PLANNING** Triangle Community Foundation

As the Triangle Community Foundation neared the end of its five-year strategic plan, the Board and leadership team wanted to ensure that the next strategic plan would address all of the future needs of the organization as well as put in place key objectives and measurements to ensure the organization was on the right track.

The Triangle Community Foundation turned to ESC for help. "We thought it would be valuable to have an outside group help us with this process," said Lori O'Keefe, Vice President for Philanthropic Services and COO of the organization. "ESC has a great framework for the strategic planning process that is very effective for most organizations. ESC also offered us a more objective perspective as we discussed critical issues and developed plans."

The Triangle Community Foundation was founded in 1983 to create positive change through community-based philanthropy. The Foundation's mission is to enhance the lives of all Triangle residents by building philanthropic assets, connecting resources with needs and providing leadership on key community issues and opportunities.

To help the Foundation through the planning initiative, ESC used its strategic planning process which includes: developing or reviewing the mission statement and vision; conducting an environmental scan of key constituencies and external trends; doing an analysis of strengths, weaknesses, opportunities and threats; defining critical issues; and developing strategic goals, action plans and measurements.

In addition to utilizing the services of ESC, the Triangle Community Foundation is a major funder of ESC activities. "We believe that ESC's sweet spot is helping small- to middle-size nonprofits, although their process is valuable for larger, more complex organizations as well. # **ORGANIZATIONAL ASSESSMENT**/ **STRATEGIC PLAN** The Lucy Daniels Center

The Board of the Lucy Daniels Center was committed to developing a long-term strategic plan. But before beginning that activity, the Board felt that it needed a broad and comprehensive organizational assessment of strengths and weaknesses.

"Our Board felt strongly that this assessment should be done first, and it would provide a structure for the strategic plan to follow," said Donald Rosenblitt, M.D., who serves as the Clinical and Executive Director of the Center.

Dedicated to helping children live emotionally healthy lives, the Lucy Daniels Center has grown to be the largest nonprofit provider of mental health services exclusively for children in the Triangle, serving more than 600 children and their families annually. The Center is both a community clinic and a highly sophisticated assessment and treatment facility.

The organizational assessment process was completed in approximately three months. ESC was then engaged to lead the development of a five-year strategic plan, which has since been completed as well.

"The organizational assessment which ESC produced turned out to be a very valuable document that we have used in our subsequent thinking and planning," Rosenblitt explained. "The four or five most important issues identified in the assessment were specifically addressed in our new strategic plan. While these issues were not new to us, it was valuable to have external consultants identify these issues in very clear and precise terms, and challenge us in some areas."

Rosenblitt had high praise for the consultants involved in the assessment and strategic planning. "I was impressed by how savvy they were, and how quickly they were able to get up to speed on our organization with its many complexities. In addition to being very capable, I appreciated the fact that they were also very respectful of our organization and people, and were committed to a collaborative process."

Rosenblitt has also asked ESC to help with communications and fundraising planning as well. "Without hesitation, I would recommend ESC to other nonprofits," Rosenblitt added. "The value received for the very modest fee is just tremendous.
